Dear Mr Pearson

Thank you for your email of 18th September 2013 regarding your investigation into CC O'Toole's expenses claims. Apologies for the delay responding to you but I have been unwell for some considerable time.

You state that Mr Dilworth of the CPS felt that there was insufficient evidence, not none, for a prosecution. It is clear he has deliberated over the evidence presented to him by you and your team and no doubt his subsequent reasoning will have been communicated to you in writing.

As the complainant involved I would be grateful for a copy of these deliberations and reasonings, or at least a synopsis.

I have no doubt that you and your team expended a great deal of time and effort on the investigation and for that I thank you. In addition to those I met is it possible to ascertain the make-up of the investigating team, e.g. were the services of a forensic accountant employed in what is clearly an accountancy based enquiry?

Would it be possible for you to expand on your phrase 'some anomalies were unearthed they were VERY(your Caps) minor'. I would be grateful if you would explain to me what you define as an 'anomaly' and quoting an example?; how many of these 'anomalies' there were over what time span?; and what you define as 'minor'?

Having filed LCC type claims yourself I would have thought you would know whether a claim is correct or not.

With reference to claiming expenses for party political duties who gave you a witness statement which informed you that this practice was permissible when self-evidently it is not?

What legal authority did you base your conclusion on?

For example was the legal authority produced to you from the LCC, local government organisations, or party political sources to support and confirm for your team that this practice was indeed permitted?

In helping provide clarity can I remind you that examination of HM Revenue and Custom rules and Guidance to Local Government Independent Remuneration Panels indicates that expenses should be paid ONLY for council business (not party political activities).

Did you also consult these quoted legal authorities when reaching your conclusion on expenses for party political duties?

I understand the allowance per mile is agreed and set by the IRP but what legal authority has CC O'Toole produced to you which appears to give him permission for what is the doubling of his journey time and mileage to County Hall and can I have a copy of that?

One might be drawn to ask why it seemed necessary to attempt the circumnavigation of the County every time he travels from home address to County Hall.

What was his explanation for this 'anomaly'?

Did you get full copies of CC O'Toole's expenses from LFRS and over what time span? Were these compared against the same time span for his LCC records to ensure that he was not 'double dipping', in other words claiming expenses for duties from both authorities on the same day, at the same time, and the same venues as rumours suggest?

Much has been made by CC Driver of the waste of public monies that your enquiry team incurred. What was the final expenditure figure in man-hours and expenses etc logged against this operation and can you let me have a copy of that as well?

If I continue to be dissatisfied and suspicious of the actions of CC O'Toole in what I know to be excessive claims or that you have not made the case or produced the conclusive evidence which clearly exists in this matter for the CPS to have a complete picture upon which to base their decision to prosecute or not then I will feel duty bound, and have the right, to seek a cold case independent review from a Chief Constable outside Lancashire via the Independent Police Complaints Commission.

You should also be advised that I now have exclusive access to a website which publishes correspondence of public interest in respect of politicians and their expenses and I intend doing so, this matter is not yet concluded.

DPC Azam Khan took copies of some of my most personal documents. I cannot recall which precise documents. In protecting my privacy I would grateful if these

are returned to me and if not copies, so that I am aware what highly sensitive documents of mine remain in public circulation.

Once again may I thank you for your team's time and effort in this matter.

I can re-assure you again that I would not be as unprofessional as appears to be insinuated and I thank-you for comment in acknowledging your recognition of the probability having met with me, unfortunately I am now in a rather difficult position:

Having investigated the matter of Councillor O'Toole's expenses and presented the evidence accrued to the Crown Prosecution Service, I felt it was appropriate to communicate the decision made by the reviewing lawyer as fully as possible to yourself as the original complainant.
