UK Disabled Fire Service Veterans National Pension Scandal

Dear Right Honourable Rees-Mogg,

- 1. In that which follows I write from the perspective of dual Nationality as do many of the disabled UK Firefighters I represent.
- It is simply appalling that such outrageous circumstance have arisen which require me to draw your personal attention, as Lord President of the Privy Council, to the scandalous misbehaviour of certain Privy Counsellors under your jurisdiction in the current Government who act in criminal complicity with senior Justices who are also Privy Counsellors.
- 3. As a Cabinet Minister you simply cannot be unaware of the circumstances I refer to.

- 4. Jointly they and you have acted to deny 11,000 UK disabled Fire Service Veterans and their 30,000 Widows and Beneficiaries access to 'due legal process' which is their fundamental Human Right to Justice.
- 5. By such corporate criminality, in denial of the Law, you have fraudulently denied these honourable servants of the Queen the right to be paid their correct pensions which since 1992 they have been underpaid in short measure to the value of 50% less.
- 6. These Privy Counsellors' sleazy activities, take little if any account of the collateral damage they are causing to the reputation of the personal integrity of the Monarch Her Majesty the Queen, the Privy Council, to the British Crown in the Commonwealth of Nations and no less than with these victims of 'Establishment' fraud.
- 7. Lest you doubt my statements I appendicise a personal copy of a requested Report placed by invitation before the House of Commons Select Committee (Public Accounts) on the 28th October 2021 who are currently engaged on behalf of Parliament in a Public Enquiry into the DWP.
- 8. I have no doubt whatsoever that both you and a Member of the Privy Council Dr.Coffey PhD Minister of State for the DWP at Cabinet are already fully aware of its contents in particular where it refers to the malign activities of Mrs Louise di Mambro OBE, Registrar to the Privy Council and the Supreme Court, who under your collective direction has exercised a pivotal role in this repugnant pogrom against these disabled Firefighters, their Widows and Beneficiaries, who have honourably served this Nation.
- 9. It hardly needs me to remind that your sworn duty to the Sovereign Lady, Her Majesty the Queen is to advise her of such shocking material matters within her dominion the only question which remains is, whether or not, you and they have personally and collectively chosen to deceive the Monarch?
- 10. Her Majesty is renowned both Nationally and Internationally for the genuine maternal care she extends to those who have served her with Honour and Distinction both within the UK and Internationally, regardless of their personal individual human cost.
- 11. Her Majesty on her Historical State Visit to my nation Ireland in May 2011 made a statement of great symbolic integrity to the People of Ireland in which she said ... "With the benefit of historical hindsight we can all see things which we would wish had been done differently, or not at all.".
- 12. What has been done to the Queen's disabled Firefighters, their Widows, and Beneficiaries fall squarely into and mirrors that statement and to this moment these great Injustices remain uncorrected.
- 13. Furthermore, as Leader of the House, it would indeed be bizarre if you choose to declare publicly that you had no such knowledge of such ominous matters when they are regularly reported directly to you by your Members of Parliament on your side of the House.
- 14. By now you will indeed be aware that this Report has been published in the Public domain and is in common circulation throughout the Opposition making the Henderson affair seem trivial by comparison when the fact of the matter is that this government has knowingly breached its Contract with the Nation's Firefighters and their Beneficiaries to the estimated amount of £4+ Billion pensions underpayments which are long overdue.
- 15. I am doubly disappointed having followed your political career over the years with its demonstrable public and personal integrity that I now find your own financial 'wheeling and dealings' are subject to Investigation by the Commissioner for Standards Ms Kathrine

- Stone OBE and her Select Committee whilst lately choosing to hold Cabinet Office in an extreme right wing government the most politically excessive since the times of Sir Edward Mosely and his Fascists in 1933.
- 16. This is not a claim to fame I would wish to be associated with. Indeed, it is intimated within the House, with justification, a disloyal Fascist Junta government rules the day which is the product of Sir George Iain Duncan Smith MP a leading Freemason of note, who initiated a bold coup d'tat driven by the elixir of power, a Junta which harms the very Nation to which all of you claim allegiance and dutiful service.
- 17. Indeed disappointment followed upon disappointment with a breath taking brass necked display of arrogant disdain coupled with the supreme denial of the Human Right to Justice by the President of the Supreme Court Lord Reed PC in the Company of his Master of the Rolls Sir Geoffrey Vos PC whose very complicit acts deny any lack of knowledge of the receipt of this Extraordinary Appeal at the Highest Courts in the Land.
- 18. Data records confirm that both illustrious gentlemen either downloaded the 203 pages of this detailed Extraordinary Appeal bundle or read it in toto on my website which simply confirms the commanded interference of Mrs di Mambro OBE in this chain of chicanery.
- 19. No doubt in a perverse juxtaposition all will claim to serve Faith, Flag, and Family yet you Mr. Rees-Mogg know better in the profession of your Faith, which we unfortunately share, of the requirement of compliance with both the Spirit and practice of the Beatitudes, to which I also refer in my Report.
- 20. It seems to me you have also chosen perversely to set the wrong example to your children when you choose to ignore the Beatitude... "Blessed are they that hunger and thirst after justice: for they shall have their fill" ...
- 21. Falsely claiming the theology of the Catholic Church is no Sinecure for your Soul as a glance at history records which is that the greatest Fascist of all time Hitler was in his youth not only a professed Catholic, but also a serving altar boy...
- 22. It is as though you dogmatically refuse to understand the lives and concerns of many 'ordinary' UK Citizens including its disabled Firefighters who daily knowingly laid their lives on the line with the tarnished expectation, under this government, that those they cared about and worked for, their families, have been so miserably short measured by denying them the intended reward that Firefighters carried in reassurance with them onto the 'Fireground' as they pushed forward into the threatening unknown...
- 23. It is my expectation in refusing to either acknowledge or respond to my correspondence, which takes personal courage, but which is consistent with your seditious denial of your sworn loyal duty to the Sovereign will simply confirms publicly who you are and what you are really worth, the price of everything, and the value of nothing?
- 24. Should the situation be confirmed that you have failed your personal duty to Sovereign then it will be my intention and the intention of other Irish Firefighter diaspora including in these defrauded disabled UK Firefighters, their Widows, and Beneficiaries to do the following...
- 25. We intend to raise this scandalous disgrace as a matter of courtesy under the aegis of the Irish Foreign Minister and thence with the President of Ireland and through his Excellency directly with Her Majesty the Queen before we all depart to the European Court of Human Rights where we will indeed receive the Human Right to Justice which is ours, though thus

far is denied us within the UK since 1992.

26. Furthermore we find it both intolerable and insulting that the UK President of the Supreme Court Lord Reed should be permitted to continue to sit on an ad hoc Committee at the European Court of Human Rights, presumably to dispense Human Rights, whilst in hypocrisy denying this very virtue of the Human Right to Justice in the UK to the servants of the Crown?
