## **Conservative Government Sedition & Fraud**

Dear Ms. Rayner,

On the 18<sup>th</sup> inst., I sent a brief note to you via your Constituency Office website. That which follows is confirmation and elucidation of that note.

I was watching your Parliamentary swearing-in on the 21<sup>st</sup> inst. It prompted a chain of thoughts which including the next Labour Party Conference in Liverpool where for several years I was posted in the UK Fire Service before being posted on to Chadderton which included serving in the Oldham constituency (Sir Steven Timms the MP) and at Ashton-under-Lyne (your Constituency) which was the third busiest station in the North-west.

During this period I lived as a single person in my caravan in Skelmersdale working closely with Dame Louise Ellman, an outstanding Lancashire Labour Leader who heavily defeated Thatcher at one point and thence I was posted to Middleton among all the splendid Lancashire people one of whom my wife Jill (sadly deceased) I was later to marry and raise a family in central Lancashire.

In your interesting biography you have described yourself in early years as 'gobby'. I have been

described as a far worse 'Paddy' when I was extremely active in the Fire Brigades Union; currently a sold out shadow of its former self.

You and I both know that to stand up and be counted takes raw physical and moral courage and when you climb out of the trenches and get to 'No Man's Land' and pause to look around all you see are your valiant comrades waving you on from the safety of their trench never having moved a foot.

You were accurate to call the Conservative Party 'scum'; let us not forget Theresa May called them worse, the 'Nazty Party'. Some of them if you care to read on, as I shall reveal, , are actually worse than that; they are a bunch of seditious conspiratorial fraudster criminals; and you ought not to have apologised.

If Starmer your unimpressive 'leader' who lacks the killing instinct, wanted to apologise *he should have apologised* or more supportively explained that the Labour Party is a 'Living Democracy' and all its Members have, within the Law, freedom of speech?

Now to the interesting purpose of my letter which I believe if you cared enough to help us to a limited degree ~ you will also invariably help the Labour Party and both their and your political ambitions. Very rarely does a political Party and its politicians get the opportunity to pull down a corrupt putsch right wing government led by Sir Iain Duncan Smith MP regardless of who thinks Truss actually runs this country; she does not.

She is simply the replacement IDS puppet after Johnson.

I am sure you will be unaware of the plight of over 11,000 disabled Firefighters and their Beneficiaries which amounts to around 40,000 potential Labour voters who will be needed shortly, or before, in the next General Election.

Your admirable Sovereign Lady Queen Elizabeth II of such unchallengeable personal and moral integrity who has sadly passed away saw fit to decorate me as an Irish Citizen with her Long Service and Good Conduct Medal for 36.5 years of Service bearing the words "For Exemplary Fire Service".

Politicians come and mostly go *having served themselves* without a thought for those they are supposed to serve and notably having little idea what it is really like in the streets where decent people struggle live and exist. But you and I know what it is really like.

Briefly ~ now entering the 16<sup>th</sup> year of this campaign ~ which is to obtain Justice for 11,000+ disabled Firefighters, their Widows/Partners, and Beneficiaries I have reached the point of more deliberate stonewalling by this Conservative government under the control of a putsch right wing government under the sole direct control of Sir Iain Duncan Smith MP.

A government he directs from the Backbenches as its lead Freemason who directs this governmental criminal fraud by sedition by directing a so called 'independent' Judiciary not to engage with us in 'due legal process' thus silently ignoring our Human Right to Justice which in any event I will take to the European Court of Human Rights(not to be confusd with the EU) of which the UK remains an active Member State.

Since 1992 successive Conservative governments having recognised that the law *will find for us* have continued to underpay pensions to the value of 49% and because Widows/Partners' PB00422 Page 2 of 5 PB©2022 will only receive the "Widows Half" they will only receive a 'Half of a Half' thus occasioning actual and real hardships by the loss of income from disability pensions these disabled Firefighters paid for, some with their lives, and by their contributions.

This scandal was finally revealed by myself in 2011, supported by an eminent *pro bono* barrister Mr John Copplestone-Bruce, a Life Member of the Inner Temple Bar who lives in Preston Lancs, to the Lancashire Fire & Rescues Service(LFRS) who immediately commenced a cover up by their senior clerk Robert Warren.

We discovered that since 1992 the LFRS had been under paying, in discrimination, some of their disabled Firefighters and Beneficiaries who were not Freemasons (like IDS) only 49% of their due pensions.

Next I uncovered the fact that this was a nationwide fraud held under the auspices of the DWP with pension underpayments due to the current value of £5+Bil a situation controlled by subsequent 'Pensions Ministers' in particular the Minister for Pensions (of longest service) Mr. Guy Opperman MP.

Opperman (a criminal barrister-and part time horse lover/jockey) has since his appointment(2017) taken the lead in this denial/cover up using the Pension Ombudsman Arter (Sir Stephen Timms MP knows all of this in detail) and has honourably to a certain extent attempted to ameliorate this scandal but still no DWP resolution nor restitution follows.

In the process of defending the indefensible Opperman was notably rewarded by Smith/Johnson recently by his unusual 'reappointment' which occurred within 1 week of resignation because Smith needed him to hold the line and keep this scandalous seditious fraud a secret but Opperman did not operate alone.

Dr. Theresea Coffey PhD PC then Minister for the DWP(2019-2022) acting under the direction of IDS took control of this scandal in conjunction with Mr Mogg-Rees and then proceeded by means of the corrupt inducement of filling the vacant post of Master of the Rolls appointed Sir Geoffrey Voss PC with the instruction to deny myself, my barrister, and my 11,000 disabled Firefighters 'due legal process' which is an unconstitutional denial of the Human Right to Justice in flagrant denial of Article 6 of the Charter of the European Court of Human Rights.

Not satisfied with the Judicial corruption of Voss and the Lord Chief Justice Burnett by inducement and bribery Coffey et all then proceeded to appointed the new President of the Supreme Court Lord Reed PC to maintain the '*denial of due process*' to this day. Clearly the late Soverign's inimitable values of integrity and morality did not extend to the ranks of the so called "Independent Judiciary" who to a man is clearly engaged in sedition(misconduct or speech inciting to rebellion) and corrupt Judicial malpractice.

Coffey, Opperman, Vos, Burnett and Reed are all daily visitors to my website (<u>www.themorningbugler.com</u>) because they all, rightly, fear exposure of their 'extra' mural activities; for example Vos retains tax avoidance/evasion offshore accounts in Barbuda for corrupt 'favours rendered' which Taypayers pay his First Class flights to this tax haven where he can study his Shylock accounts.

The media editors, as you will certainly be aware, do as they are told.

Vos(alleged horse breeder) ,Coffey and Opperman share a love of horses and in Coffey's case she has Parliamentary undeclared business interests in a stud farm in Warwickshire with her Arab business partners...

They are all as I have lawfully published and will publish more 'criminals to a man and woman'...'scum' hardly makes the grade and no apologies will ever be forthcoming.

This extraordinary week Opperman announced in his words that he had been ... "relieved of his duties" on the 8<sup>th</sup> of September whilst still under the direction of PM Johnson/Smith; delayed he stated by the death of the Sovereign... " to return to the best job in the world being MP on the Backbenches".

Was that, in weighing his options, because he will say he had been duped into supporting this fraud by Coffey; or that he was prepared to speak out as the pressure grows; or was it at the behest of Coffey acting on the instructions of IDS to keep his mouth shut or face the prospect of being disposed of as an MP and/or disbarment by the Bar Council and thus have no discernible personal income?

Your Leader, if I am to conclude rightly, is fully aware of all this because he also is an avid 'Bugler' reader but why does he take no action? I am not greatly impressed because he lacks a cutting edge...but you do not.

During this desperate cover up by Johnson et al, unsolicited Dame Meg Hillier DBE, Chair Public Accounts Select Committee asked me to submit the facts to the PAC and she received a comprehensive response both at the PAC and by Recorded Delivery; at her Constituency address by RD and by hand delivery. Dame Hiller never acknowledged receipt of a single document which let us not forget she asked for; nor did she submit them for consideration to PAC; in fact she discourteously simply did nothing! Which Party does she work for?

The only person and Party to respond courteously, encouragingly with practical help whom I actually met was Liberal Tim Farron PC...

Finally if we are worthy of your support can I suggest to you that on the first suitable occasion you find yourself opposite Coffey at the Despatch Box in your respective roles, and without consulting Starmer, you simply ask Coffey what did she, Smith, Opperman, Vos, Burnett, and Reed know about this criminal governmental fraud and its associated sedition and when she fails to recover any composure you press home the attack with even more simple questions... or supported by trusty and primed backbenchers with the facts...

Coffey a Convent educated youth at the Private school in Crosby Liverpool where I was stationed nearby seems to draw the line at her eternal Soul when she comes to lying though she is a master manipulator bar none, or Smith, and is the weak link and is an appallingly poor public performer and perspires copiously when in any form of denial.

Shortly I will be writing as a final precursor on my journey to the European Court of Human Rights who do not have a sympathetic view of the UK or its Judiciary, to The President of the UK Supreme Court Reed and his companion in denial Master of the Rolls Voss asking them within a stipulated time frame to publicly justify in detail their corrupt judicial practices?

Of course they will not thus fulfilling the ECHR requirement that the judicial process has been exhausted in the named Member State, the UK.

Meantime I am at your disposal and prepared to travel at my expense to provide a full briefing because the original 'Architect' of all this fraud in 2007 called Robert Warren still resides in Stockport and remains in the employ of the Lancashire Fire & Rescue Service, a 'Service' which remains another avid daily Reader of the Bugler because they fear a Public Independent Inquiry and because of the 2000 documents I have in my website Publicly available Libraries which is hard evidence freely available to anyone who cares to download them all.
