An Open Letter ~ To the Houses of Parliament.

The Right Honourable Ms. Penny Mordaunt PC MP Lord President of the Privy Council. Leader of the House of Commoners. St Margaret St, London SW1A 0AA. My Reference: PB00423

## Formal Complaint ~ Parliamentarians & Judicial Misfeasance Egregious Abuses of Power by Corruption

Leader of the House,

Dear Madam, you are The Leader of the House of Commoners who acts as the government's representative in the House by Statute, sitting on the House of Commons Commission, Public Accounts Commission, and the Speaker's Committee, etc.

You also direct Mr.Daniel Greenberg CB the Parliamentary Commissioner for Standards [an independent officer of the House of Commoners] who applies the Seven Principles of Public Life [the Nolan Principles] to all politicians under your/his jurisdiction.

Namely, Selflessness; Integrity; Objectivity; Accountability; Openness; Honesty; Leadership.

Under the publication a 'Guide to Parliamentary Work', the Committee of Privileges is tasked by the 'House' with the investigation of potential contempts and breaches of Privilege and Principles, whilst considering wider matters relating to personal parliamentary conduct, or as instructed by the 'House', and then you.

The serving politicians and judiciary, whom I name, have sullied and breached every single one of these Principles of Virtues and as a consequence have brought the esteemed House of Commoners into International disrepute which requires that their maleficent misconduct be publicly called to account.

This Guide is provided to all, including Civil Servants whom I also name, of both the Government and the Judiciary who also have pertinent questions regarding their individual probity and integrity to answer.

I represent 11,000 UK disabled Firefighters, their Widows [half of a half pension-the 25% underpayment] and Beneficiaries and have done so for the last 17 years in this troubling breach of good faith and the Law.

The nub of the matter is that successive Lancashire Fire Authorities [where this criminal fraud originated] and successive UK governments have knowingly underpaid these victims of institutionalised fraud 25%+/- less than their due pensions since 1992 to a total value of approximately £5Bill+ excluding 8% Statutory compound interest.

With an exemplary Life Member of the Inner Temple, a pro bono Barrister of the highest integrity, I have repeatedly attempted to use the political/judicial system to obtain the fundamental Human Right to Justice, due process, because I know that the Law finds for us.

If, there was governmental doubt, the Secretary of State for the DWP, The Rt Hon M. Stride PC MP, his responsible Ministers, Mr. G. Opperman MP, and Ms L.Trott MP all have a Statutory duty under the Public Service Pensions Act 2013 which *compels them* to resolve any pension dispute by taking the issue to the High Court on a Point of Law. They could do so promptly ex parte, if they desired, but knowingly they refuse to do so.

I am not a Freemason but throughout I been opposed at every level by Freemasonry, indeed ironically many of whose male Brethren I was asked to and actually represent are suffering from this criminal fraud imposed on them by their own 'benevolent' organisation.

The opposition takes the form of stonewalling obmutescence and involves current Lancashire politicians of all Parties but also named Members of Parliament of this current government in association with named senior Justices all of whom are Members of the Privy Council e,g, rising from the Master of the Rolls, through the LCJ, to the President of the Supreme Court.

Politicians include former PM Johnson under the manipulative control of Sir Iain Duncan Smith PC MP [the Parliamentary lead Freemason] who also directs and controls Sir Jacob Rees-Mogg; Dr. T. Coffey PhD PC MP; The Rt Hon M. Stride PC MP[DWP SoS]; his responsible Ministers Mr. G. Opperman MP[Employment]; Ms.Laura Trott MBE[Pensions Minister] all have in their personal possession the Recorded Delivery Folio attached to this Formal Complaint.

Not a single one of these named persons including PM Sunak, in personal possession of this folio, has either acknowledged receipt of this folio or taken the required Statutory action.

Parliament has simply failed us by its failure to apply standards of discipline leading to selfdiscipline and common honest decency to these rogues.

In addition, I have documentary evidence that confirms the misuse and abuse by intrigue of the Privy Council's functionality under the control of the recent PC Registrar Mrs Louise de Mambro OBE and unfortunately involving current Privy Councillors [named above] some who are also Freemasons under the last, and now current Regency.

Madam, can I with respect suggest that having read and assimilated our Complaint, that you action the attached folio of parliamentary evidence presented to you as a Formal Complaint on PB00423 Leader of the House Page 2 of 85 PB©2023

behalf of those I represent and as an example of the state good conduct has fallen to.

I also propose to place this criminal evidence before the Serious Fraud Office and the Metropolitan Commissioner of Police and suggest to you that you would be failing in your solemn sworn duty to the new Sovereign if you failed to inform him that his Subjects are being disenfranchised and criminally defrauded of their pensions which they have paid for and are entitled to by law, *after*, having served this Nation with Honour.

This is obviously the age of the breach of Public trust in the UK politics of which you have rightly spoken publicly and appear to be prepared to take action against?

To reiterate your Leader of the Conservative Party PM Sunak has a Recorded Delivery of my folio which he chooses neither to acknowledge nor respond to. How can he continue to act in such a failure of Ministerial duty and discourtesy and still call himself a Prime Minister?

I am taking the exceptional step of copying this Open Letter and folio to the Chair of the Privileges Select Committee, Ms. H. Harman KC PC, who you will also be aware is a Member of His Majesty's Privy Council.

My final steps are to publish a serialised version of this folio which I have sent to those in authority [without response] which is evidential proof of their seditious criminal activities.

Finally having exhausted the UK judicature which has by obmutescence denied us our fundamental Human Rights to Justice under Article 6[a fair trial], I will take the matter to the ECHR.
