Glenn made it alone to one of the upper floor windows where he was rescued by colleagues, though he was severely burned, and subsequently invalided from the Service with years of surgery and rehabilitation to follow.

Frankly this is a grotesque act of inhumanity approved by Wilkinson and Holland. Even I would not have believed that these contemptible people would stoop this low but they have exceeded their own contemptible immorality.

These thugs think they can threaten what is left of this real man's world. If our will to continue to fight was in anyway diminished, which it is not, this repulsive and repugnant act will only strengthen our steely will to see all these people called to account when you take office.

It seems there is no level that Wilkinson and Holland will not stoop to.

A public enquiry is inescapable.

It may be a matter of some interest that Glenn's wife is a freelance journalist.

Our immediate purpose remains clear... to vote Labour out of control at County Hall and on the Combined Fire Authority ...simply because they have no common humanity...
