Dear Mr. Kavanagh,

I note I have not yet received acknowledgement from the AC of my informal email of the 14th inst., or the supply of the necessary papers to initiate a DPA data subject request?

- [1] This is in the matter of my Fire Service pension in respect of the Injury Pension Award.
- [2] My pensions are statutorily paid by the Lancashire County Council Pensions Services(LCC PS) whilst acting as Contractors to the Lancashire Fire & Rescue Service(LFRS) which is itself governed by the Lancashire Combined Fire Authority(CFA).
- [3] I am in legal dispute with the CFA and I am represented by Thompsons the Solicitors of London.
- [4] During this dispute the CFA decided, without prior legal justification to me, or without informing me of their intentions prior to misusing the NFI, to obtain my subject data from the DWP. This is the matter which lies at the legal heart of this dispute.
- [5] In so doing and in the defamatory statements they have made they have exposed themselves to a pre action protocol "Letter of Claim" for Defamation which has now been lodged with the Lancashire Combined Fire Authority(CFA) who are legally responsible for the LFRS and its agents.
- [6] It is to be assumed that the AC would not have used the NFI data matching mechanism on my subject data records held by the DWP *without* substantial and verifiable *legal* justification by the LCC PS/LFRS/CFA. The AC should, under my FOIA/DPA Requests, specifically provide me with copies of the documentary evidence and legal justification to support that joint action by the LCC PS/LFRS/CFA/DWP.

In the event that such an AC justification document, specific to my case, does not exist, you should now supply me with a positional statement supporting and justifying *your* actions in respect of this data matching exercise.

- [7] Accordingly I have initiated FOIA and DPA subject data Requests with the CFA; LFRS; the LCC PS; the DWP; and I now do so with the AC.
- [8] I request under the Freedom of Information Act 2000 that the AC release copies of <u>all</u> correspondence, records, contemporaneous notes, and vox tape recordings

between the AC and the CFA; the LCC PS; the LFRS; the DWP; and any and all other agencies, whether directly or indirectly involved. This list is not intended to be exhaustive.

In so much as these records relate to this subject of LFRS pensions and Lancashire Fire Service Veterans, other than in so much as they relate and refer to an individual, (redaction is assumed) though not excluding my specific pension or my specific public records.

[9] I request under the Data Protection Act 1998 that you release to me copies of all my subject data and <u>all</u> correspondence, records, contemporaneous notes, and vox tape recordings between the AC and the CFA; the LCC PS; the LFRS; the DWP; and <u>any and all</u> other agencies, whether directly or indirectly involved. This list is not intended to be exhaustive

In so much as they relate to this subject of my LFRS pensions.

[10] You should be advised that it is my legal team's intention to cross reference *all* this data received from *all* the agencies, whether or not directly referred to above, or whether or not named; to ensure that no 'economy of response' occurs particularly in that data which is supplied by the LFRS/LCC PS.

[11] Included is a NFI source document to initiate the AC search.
