Without seeing the letter from the Audit Commission it is difficult to fully respond as my response is based on guess work

I presume the issue has arisen as a result of a letter from Mr Burns to the Audit Commission but it might be as a result of a letter LFRS have sent to the Audit Commission

This is because in preparation for our legal action we wrote on 20 January to the Audit Commission (including a copy of the screen print) asking for them to release some information (as depending on their answer we would need to consider whether or not it is appropriate to include them in our process). We also do not want to be challenged that we have not done all we can in our power to gather the information, effectively high lighting Mr Burns obfuscation.

was not aware that a screen print should not be disclosed. Nor do I understand the reasoning. We were in contact with Mr Burns concerning our inability to calculate the element of his pension that was related to a service injury. During this process we received as part of the NFI process the information that he was in receipt of a benefit payment. The benefit was one that ordinarily would be deducted from his injury pension. We wrote to Mr Burns in June bringing this to his attention and asking for his explanation. We have not received a direct response from him to this letter or the repeat.

The reason for disclosing the information to Mr Burns was to give him the opportunity to explain the circumstances and to offer any explanation as to why the amount should not be deducted from his injury award element.

Although I could not see any explanation I did not jump to the conclusion that there was no explanation. We are under an obligation to ensure proper discharge of public funds and we were following the Audit Commission guidance in that the match indicates an inconsistency that needs to be explored hence asking the individual for an explanation. The nature of Mr Burns interaction with the service was such that it was thought mentioning the Audit Commission NFI would improve the chances of him responding

On a point of accuracy the paragraph that ends with the word "suspended" should be amended along the lines of "as LFRS were unable to accurately calculate the amount, if any, due "
