Thank you for your letter of 19th November to Bob Neill on behalf of Mr Paul Burns, 7 Kings Drive, Fulwood, PR2 3HN. Your letter has been transferred to me as matters concerning the Firefighters' Pension Scheme form part of my Ministerial responsibilities.

Mr Burns asks what statutory powers exist within the Firefighters' Pension Scheme 1992 which require pensioners to notify the Fire and Rescue Service of the Benefits they receive and what legislation exists requiring pensioners to sign up to providing such notification.

As Bob Neill explained in his letter of 17 August, which you attached to your letter, under the terms of the Firefighters' Compensation Scheme 2006, which is now the relevant statutory scheme for the payment of injury awards to firefighters who are injured on duty, the fire and rescue authority, which employed the firefighter, is required to reduce the amount of any injury award by the amount of any benefits paid by the Department for Work and Pensions. This ensures that the person does not receive duplicate benefits for the same injury.

The system can only work effectively if the person receiving an injury award informs the authority of the benefits received from the Department for Work and Pensions, or gives the Department permission to notify the authority of any change in the benefits paid.

of the pensioner fails to co-operate in this matter, the authority will need to take reasonable steps to ensure that it does not overpay, and if necessary, to recover any overpayment.
